### GENERAL PRICE LIST

These prices are effective as of **January 1, 2016** and are subject to change without notice.

The Federal Trade Commission (FTC) and the New York State Department of Health both require that certain disclosures be made by funeral providers on the general price list. Although these disclosures are similar, they are not exactly the same. This general rice list contains both sets of the required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters "FTC".

The goods and services shown are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.

This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

(FTC) - The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements that you select will include a charge for our services.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

(FTC) - This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers, and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

<u>NOTE:</u> In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements such as viewing or an open casket funeral, embalming may be required by the funeral firm.

(FTC) – "Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial."

Preparation of remains, unless selected, is not required for direct cremation or for immediate burial.

Our fee for the basic services of the Funeral Director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral, e.g. cemetery, crematory, vault companies, and others as required.

(FTC) – "This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)"

#### LIMITED SERVICES:

# FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME: ......\$ 1,945

This charge includes the local transfer of the remains to the funeral home, staff services, securing necessary authorizations, local transportation to point of shipment. The charge does not include shipping charges or additional items of service, merchandise, facility use and livery that the customer may wish to select.

Transportation beyond local point of shipment will be billed either as livery or common carrier charges pending upon the forwarding location. Local point of shipment is up to 15 miles. Additional mileage is billed at \$3.00 per mile.

# **RECEIVING REMAINS FROM ANOTHER FUNERAL HOME:** 1,795

This charge includes basic local transportation of the remains to the funeral home and/or place of local disposition, staff services, and securing of necessary authorizations. The charge does not include additional items of service, merchandise, facility use, and livery that the customer may wish to select

Transportation beyond a local place of disposition will be billed as livery charges. Local place of disposition is up to or within 15-miles. Additional mileages billed at \$3.00 per mile.

### **PAYMENT POLICY**

All financial arrangements for payment in full should be settled prior to the day of the service. We will provide an itemized agreement of funeral home charges. In order to provide you with financial flexibility, we offer the following choices to satisfy financial obligations prior to the services:

Cash or Check Credit Card (VISA, Mastercard, or Discover); Assignment of Insurance to the Funeral Home; PrePaid-PreArranged Funeral Arrangements.

<u>Cash Advances</u>: are third party charges which the funeral home has no control over. Except for prepaid funeral arrangements, we request you pay Cash Advances directly. For your convenience, we will provide an estimated cost of Cash Advance expenses prior to the service, which may include Cemetery/Crematory, Clergy/Church Honoraria, certified Death Certificates, Musicians, etc.

<u>Estates</u>: It is the policy of the Gilpatric-VanVliet Funeral Home not to wait for payment from an estate.
